I understand that in my position as a coach/team staff member, I must act in accordance with the following code:

1. Show respect for players, cheerleaders, officials, parents, other coaches, and/or staff.
2. Respect the integrity and judgment of game officials, before, during and after the game or competition.
3. Establish, model and/or instruct fair play, sportsmanship, and proper conduct.
4. Establish and maintain player/cheerleader safety and welfare as the highest priority.
5. Provide proper supervision of players/cheerleaders at all activities or until released to parents.
6. Use extreme discretion when providing constructive criticism and when reprimanding players/cheerleaders, in accordance with established rules.
7. Maintain consistency in requiring all players/cheerleaders to adhere to the established rules and standards of the game to be played.
8. Properly instruct players in the safe use of equipment and playing rules.
9. Instruct and adhere to established rules and standards.
10. Refrain from possession and/or use of alcoholic beverages and/or drugs before and during all games or practices.
11. Assist in maintaining parent/crowd/team control to insure an orderly and peaceful game. This includes refraining from the use of profanity, vulgarity, and other offensive language and gestures at all times.
